August 28, 1832 Jacob Marsh of Pelham, New Hampshire, seventy-two years of age, deposed:

that he enlisted in March, 1776 "to go to the Castle in Boston Harbor to repair the fort there which had been destroyed by the British," for three months; served two months; was taken sick and allowed to return home;

that in 1777 about thirty men enlisted from the town of Pelham "to assist in capturing Burgoyne's army;" chose their officers before they started, as follows:

Captain, Amos Gage  
Lieutenant, Robert Nevens and  
Captain, Thomas Spafford of Pelham, acted as Orderly

Sergeant. "Some men from other towns joined us to make up the company and some of the officers were chosen from there;" marched to Bennington, Fort Miller and Fort Edward, where they staid most of the time. "We afterwards crossed the North river where we were in hourly expectation of an engagement with the Hessians, but no battle took place

as the British army surrendered. While at Fort Edward a party of our men captured and brought in over fifty Indians and a number of British Soldiers who had been wounded;" was verbally discharged at the end of his time;

that in June, 1780, he enlisted for six months; went to Worcester, Mass., from whence a Sergeant "conducted us to West Point, where Arnold commanded. We were there mustered and attached to Major Scott's company, commanded by Lieut. How, Col. Cilley's regiment and were stationed in sight of the city of New York. After Arnold's villainy was discovered the regiment marched in great haste to West Point" where they staid some time then went to Soldier's Fortune where he received his discharge, which he has lost;

that in August 1781 six men were called for from Newburyport, Mass., to go to West Point"...."Capt. Whittier of Methuen was employed by the men whose duty it was to go, to procure men to go as substitutes for them. Six men from the town of Pelham engaged to go:

and myself;" went to Newburyport and enlisted for three months; then to Worcester where they passed muster and were put under Lieut. Davis then to West Point, where he served out his term and received a discharge, which he has, also lost;

that he was born August 22, 1760 in Bradford, Mass., moved to Pelham before the Revolutionary war.

From memorandum on file it appears that Jacob Marsh,  
seventy-nine years of age, was living in Pelham in 1840
