**THE STATE OF NEW HAMPSHIRE
TOWN WARRANT**

To the Inhabitants of the Town of Pelham, in the County of Hillsborough, in said State, qualified to vote in Town affairs:

(L. S.)

You are hereby notified to meet at the Town Hall in said Pelham on Tuesday, the 11th day of March, next, at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing, and as provided by law.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same. That is, to see if the town will vote to accept the town budget as prepared by the Budget Committee, and to take action thereon.

3. To see if the town will vote to raise \$569.34 as the town's share of Town Road Aid (T.R.A.) to be used with a sum contributed by the State, \$2,277.36, for the improvement of Class V, town roads.

4. To see what disposition the town will make of the \$2,000.00 Post War Highway Fund now held in a separate account by the Town Treasurer.

5. To see what disposition the town will make of the money in the hands of the 200th Anniversary Committee.

6. To see if the Town will require cement vaults to be used at burials in the cemeteries owned by the town.

7. To see what action the Town will take in regard to the report of the building and zoning laws committee submitted to the voters at this meeting.



8. To see if the Town will vote to elect one highway agent in March, 1948, instead of two as at present.

9. To see if the town will authorize the selectmen to secure the assistance of the State Tax Commission in reappraising the taxable property in the town in order to secure greater equality as between taxpayers, and to insure the assessment of all the property in the town on the same standard of value and appropriate money to pay for the same.

10. To see if the town will vote to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting, and make appropriation to cover the expense of the audit.

11. To see if the Town will vote to raise and appropriate the sum of one hundred (\$100.00) dollars to be used toward the eradication of poison ivy on public grounds and road sides.

12. To see if the Town will authorize the selectmen to distribute the inventory blanks when they make their annual appraisal in April.

13. To see if the Town will authorize the selectmen and town treasurer to borrow necessary money in anticipation of taxes.

14. To see if the Town will vote to grant a discount on all property taxes of the 1947 list, paid in full, 2 percent on or before August 1, 1947, 1 percent on or before October 1, 1947 or take any other action relative thereto.

15. To transact any other business that may legally come before said meeting.

BUILDING REPORT

Report of Committee on Article 19 of the 1946 Warrant.

Your committee makes the following report:

Building and Permits

Any person desiring a building permit shall first submit a plan of the building to be erected, stating location, size and material to be used, and for what purpose the building is to be used.

No building shall be built nearer than 50 feet from the center of the traveled roadway, without public hearing on the same.

No dwelling house less than 400 feet from the highway which is valued less than \$1,000.00 exclusive of cellar, shall be permitted.

No building shall be erected less than 400 feet from the highway without first obtaining a building permit.

Chimneys shall be erected with proper linings.

Electric wiring and plumbing shall comply with the state laws.

No loam shall be stripped from land to leave less than six inches of loam.

No sand banks shall be opened less than 25 feet from the highway.

This Board of Zoning and Building shall be appointed by the Selectmen of Pelham, in compliance with Chapter 53, Section 4 of the Revised Laws. Also see Page 218, Chapter 4:

The fee for the issuance of a building permit shall be \$1.00, the said permit shall have a signed statement that the fee is paid under the permit itself, by the person authorized to issue the permit.

This board shall meet once each month at the town office at the same time as the selectmen meet.

REPORT OF SUPERINTENDENT OF SCHOOLS

Pelham, New Hampshire

February 17, 1947

To the School Board and Citizens of the School District
of Pelham:

I submit to you my first report as superintendent of
your schools.

The schools have operated in the usual fashion. It
was fortunate for us that Mrs. Ruth Richardson, an
experienced teacher, became available to take the Gage
Hill School when Miss Jezak asked to be released late
in August. The earnestness of our teachers in lead-
ing their pupils on the path of learning is to be com-
mended. Certainly we must show appreciation by
offering payments in keeping with the professional
nature of the service rendered.

The problem of adequate housing for our schools is
still with us. The present plan has worked smoothly.
Yet the lack of water at each school site is unfavor-
able. Inadequate janitor service places a further
burden upon the teacher. A fine step forward was
taken in having a new teaching system installed at the
Junior High building. This has proved to be efficient
and economical. Since this plant can carry some
added load and is capable of expansion, there would be
no loss if a changed building program were to be
adopted. Probably we should look toward a consoli-
dated school as our best solution of the housing
problem.

I would like you to know that the teachers have been
responsive to my suggestions; that understandings
have been possible when I could confer with parents;
and that I am grateful to the members of the School
Board for their full acceptance of responsibility for
the welfare of the children. The co-operation of all
makes possible the development of the children into
useful citizens.
