Regulating Cemeteries and the interment of  
deceased persons.

Sect 1<sup>st</sup> It shall be the duty of the Selectmen  
in the first week of April in each and every year,  
to appoint one person as Sexton, who shall be a  
resident of the Town, for the several cemeteries  
belonging to said Town, and fill all vacancies  
in said office, whose appointment shall be in  
writing, and his compensation by them fixed  
therein, the same to be paid from the Treasury of  
the Town, shall hold his office for the term of  
one year unless sooner removed by said Selectmen  
shall perform all the duties and be subject to all  
the liabilities herein after described.

Sect 2<sup>d</sup> It shall be the duty of said Sexton  
to provide a suitable horse and harness to be by him  
used in a hearse furnished by said Town, and  
attend with the same all funerals in Town when  
desired, and keep said hearse in good order, also he  
shall be liable to said Town for all damages said  
hearse may sustain by reason of the carelessness or  
negligence of himself or driver.

Sect 3<sup>d</sup> Said Sexton shall dig all graves in said  
Cemeteries shall attend himself, or by substitute  
all burials in the same and render all necessary  
assistance and conclude all interments in a  
respectable manner.

Sect 4 The entire care, control and supervision

of the Cemetery of the Town shall be vested in a board of (6) six trustees, (2) two to be chosen at each annual meeting for the term of (3) three years each.

Sect 5 It shall be the duty of the Trustees to open for sale and use such part or parts of the addition to the Cemetery at such time or times as they shall determine.

Sect 6 They may sell for burial purposes to any inhabitant of the Town a lot in said addition for the sum of ~~two~~ <sup>not less than one</sup> dollar, and they may sell to such persons as they see fit who are not inhabitants of the Town a lot for the sum of ~~ten~~ <sup>not less than \$10</sup> dollars, and make a suitable conveyance of the same and keep upon a plan suitably numbered and such other record as is suitable, all such sales or conveyances.

Sect 7 No conveyance of any lot or right in such lot by any other person than the Trustees aforesaid shall be of any avail, and any lot not used by the person or family first purchasing the same shall revert to the Town, and the Trustees may repay the person so purchasing it the amount paid for the same.

Sect 8 The Trustees may make suitable Bylaws for the conduct of their duties, and such regulations, as they deem necessary for the government and guidance of lot owners in making improvements

Sect 9. The Trustees shall have control of and expend all moneys appropriated for the care of the Cemeteries and shall make a report of their doings and pay all money in their hands to the Town Treasurers before the close of each fiscal year.

Sect 10. If any lots remaining unsold in the Present Cemetery may be sold by said Trustees for (2) two dollars each.

Sect 11. These Bylaws shall take effect and be in force from and after their passage and all Bylaws or Votes of said Town inconsistent herewith are hereby repealed.
